Dear Russ:

Thank you very much for your letter of 14 February. It was interesting to hear from you and to know what you're doing. I have read some of the things you have referred to, although I never got to read the Saturday Evening Post pieces that were about the 306. If those are ever put together and if copies are available, I sure would like to have a chance to read them.

My own career with the 306 and with the Clay Pigeons 367 Squadron was not too spectular. We arrived there early July, flew our first mission on the 4th of August, and were shot down the 12th of September. I made a total of 12th missions in that period. I have listed them all in the history sheet that you gave me. Indicative of my short tour of duty, we were shot down about 35 kilometers northeast of Berlin and were taken to the interrogation center at Oberursel near Frankfort, Germany. We were given the standard interviews, incidently, on which we had been excellently briefed by Air Force intelligence. I was quizzed concerning the name of our group CO. After two days interrogation, they told me it was a Colonel Thompson. I don't remember ever having met the gentleman. I had a diary covering part of the time in PW camp, which I can't seem to find at the moment. I'll give it some more search, and if I can find it or can identify any of the other living members of the 306, I'll be delighted to pass their addresses on to you.

Dear Stan:

Thanks for the response. Did I send you one of my Missing Air Crew forms? If not, I enclose one.

I am particularly interested in responses to this because there is nothing in the official records that really tells anything about crews that were shot down--other than that they were. I am enclosing the Missing Air Crew report for your crew.

But I would like to know more about what happened in the plane, how you got out, and subsequent events.

I am also particularly interested in the Ruhland raid, as I was flying in the low squadron with you that day. We got back, with only a 20 mm hole in one wing tip, but it was quite a day. Also, this morning I wrapped up three days of lecturing about that particular raid to a history class at the college where I now am working.

When I was in c dlege I wrote a narrative of my combat tour, and devoted a chapter to Sept. 12, which you may also find of some interest. A lot happened that day, and was the last time that the 306th really got clobbered. It was also one of the last fighter attacks.

Let me hear from you.

Previously hit by flak. FW 190's hit nose destroying canopy and set electrical fire. Then they approached from rear with 20 MM fire.

Describe conditions in the plane as completely as you can: Large holes were shot in fuselage, radio room was on fire, ball turret was hit, making it impossible for gunner to see. Radio room was set on fire. Radio man and waist gunner exited through waist door. Ball turret gunner got out of his turret in time to see them fall free. He went to tail - found gunner dead - and jumped from tail exit. All controls were shot out except an aileron tab.

How and where did you leave plahe?

I jumped out nose (side) exit following bombardier, engineer and navigator. Pilot White was last.

What happened when you got on the ground? Lit in woods near factory manned by refugees from Scheweigs-Holstein. Factory guards captured me and called for soldiers who took me to nearby town.

Did you meet any of your crew mates? In town met Pilot White, waist gunner, bombadier and navigator. Don't remember when we met radio man. Met turret gunner at end of war when T came out of wash tent at Camp Tucky Strike. How were you treated, if captured?

Treatment O.K. Close to briefing.

Any additional details, reminiscences, letters, or documents of these events would be appreciated. If you do send such materials, I will copy them and put them back in the mail to you within 24 hours.
