1. The provisions of section I of G. O. No. 84, Hq ETOUSA, dd 16 Aug 1944, quoted below, requiring service coat insignia on authorized battle jackets will be complied with: "7. A tailored jacket, of approved material and of the type heretofore issued experimentally in this theater, may be worn in lieu of the service coat. The buttons on such jackets will be of dark colored material. Buttons of gold or gold colored metal will not be worn. Insignia, decorations, badges, etc, will be worn as prescribed in regulations for the service coat."
